#### PURPOSE

The Environmental Policy aims to define and establish the company's environmental commitments and guidelines to promote best environmental practices in the development of our activities throughout the value chain.

This Policy demonstrates the organisation's commitment to the care and protection of the environment, as well as its quest to improve its environmental performance.

#### 2. SCOPE OF APPLICATION

This Policy applies to all Prosolia Energy Group companies, as well as to other equivalent forms of joint collaboration, when the company assumes operational control. The organisation will also make every effort to ensure behaviour aligned with this Policy among its stakeholders.

## 3. COMMITMENTS AND PRINCIPLES OF ACTION

Prosolia Energy is firmly committed to proper environmental management of its impacts throughout the entire value chain. Therefore, the organisation seeks to have a positive impact on the environment, promoting and developing solutions that respond to current climate challenges.

The purpose of this policy is to formalise the company's commitment by establishing guidelines to ensure proper environmental management:

- Contribute to climate change mitigation and decarbonisation of the business model by gradually reducing the intensity of greenhouse gas emissions;
- To guarantee at all times compliance with the legal requirements in force in any of the geographies where the group is present;



- Implementation of an adequate environmental management by identifying, assessing and managing the positive and negative environmental aspects and impacts of the activities;
- Promote the circular economy, optimising the sustainable use of natural resources, minimising as far as possible the generation of waste and managing the waste produced in a way that prioritises reuse and recycling;
- Protect and conserve biodiversity, minimising impacts and dependencies on ecosystems, through the application of management measures based on the mitigation hierarchy (avoid, minimise, restore and compensate) throughout the life cycle of projects, and especially in projects developed in protected areas;
- Promote environmental commitments aligned with those established throughout the value chain (customers, partners, suppliers and other business stakeholders);
- Pay attention to water consumption as a resource, promoting its sustainable management, minimising its consumption and mitigating the impact on its quality;
- Train and sensitise employees to raise awareness of the protection and importance of caring for the environment and the fight against climate change;
- Contribute whenever possible to the socio-economic contribution of the territories and to the generation of positive impacts on the local community.

#### 4. RESPONSIBILITIES

Prosolia Energy's management is responsible for supervising and guaranteeing the incorporation of the commitments of this Policy in the company's commercial operations. It is also responsible for providing the necessary resources for the correct implementation of this policy.
